FACILITY: Penobscot Bay YMCA, 116 Union Street, Rockport, ME 04856 SCY 8 Lanes.

POOL LENGTH CERTIFICATION: The length of the competition course without a bulkhead is in compliance and on file with USMS in accordance with articles 105.1.7 and 106.2.1.

TIMING SYSTEM: The primary timing system will be automatic timing. Times from this competition will be eligible for USMS record and USMS Top 10 consideration.

ELIGIBILITY: All participants must be age 18 or older.

AGE-DETERMINING DATE: The swimmer's age on February 15, 2026.

ENTRY FEES: \$35/person (for entries received by 11:59 pm on Wednesday, February 11, 2026. Late entries and/or deck entries are \$45. Please make a check or money order payable to Penobscot Bay YMCA - Aquatics. Checks will not be processed until after the meet. Checks will be voided if a swimmer is unable to attend. Deck entries must be in by 9:00 am. No deck entries will be accepted after this time

ONLINE ENTRIES: All swimmers must register and pay for the meet online through [Registration](#). Registration is required to participate. Meet [Registration](#) (Click here to register) . PAPER ENTRIES: Deadline date for mailed paper entry forms postmark by February 11, 2026.

ENTRY LIMITS: 5 individual events.

CHECK-IN: Swimmers already entered in the meet need to check in by 9:00 am.

Warm-Ups: Morning warm-ups will be in the main pool at 8:30 am, with adjacent lanes used if available. The therapy pool will be open as a warming pool, but its higher temperature makes it not suitable for full warm-up or warm-down.

SEEDING: Swimmers will be seeded in heats according to times regardless of age or gender. Heats will run slowest to fastest. We will seed the meet at 9:00 am and immediately post heat sheets. This will ensure the heats are filled.

SCRATCHES: No penalty for scratches

RELAYS: Men's, Women's, Mixed (two men plus two women). Relay deck entries will be accepted.

SCORING: This meet will not be scored

HEAT SHEET: Heat sheets will be posted in multiple locations on the pool deck prior to the start of the meet. Swimmers are responsible for checking their event, heat, and lane assignments.

Release Form and Waiver of Liability and Indemnity Agreement

IN CONSIDERATION of being permitted to utilize the facilities, services and programs of the Penobscot Bay YMCA for any purpose, including, but not limited to observation or use of facilities or equipment, or participation in any off-site program affiliated with the Penobscot Bay YMCA, the undersigned, for himself or herself and any personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering or participating will, inspect and carefully consider such premises and facilities or the affiliated program. It is further warranted that such entry into the Penobscot Bay YMCA for observation or use of any facilities or equipment or participation in such affiliated program constitutes an acknowledgement that such premises and all facilities and equipment thereon and such affiliated program have been inspected and carefully considered and that the undersigned finds and accepts same as being safe and reasonably suited for the purpose of such observation, use or participation.

THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING:

1. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE THE PENOBCOT BAY YMCA, its directors, officers, employees, and agents (hereinafter referred to as "releasees") from all liability to the undersigned, his or her personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefor on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in, upon, or about the premises or any facilities or equipment therein or participating in any program affiliated with the Penobscot Bay YMCA.

THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE due to negligence of releasee or otherwise while in, about or upon the premises of the Penobscot bay YMCA and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the YMCA.

THE UNDERSIGNED further agrees that the RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as permitted by the law of the State of Maine and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made.
